INCOME TAX- Free Preparation - by CVITP volunteers

Mondays only - March 2 - April 27 9:00 am - 12:00 pm.

First come, first served

- **Electronic Filing only** – if previous years need filing, bring it.
- **MUST bring all your Income Tax receipts; wait until you have all of them.**
(This includes donations (total by charity) & medical (total by type/person))
- **Married – bring your spouse** - your spouse's tax information is absolutely necessary.
- **Limits: - \$ 40,000 single**
- \$ 55,000 single adult with dependent child
- \$ 55,000 couple / \$ 5000 each additional dependent

Simple tax situations:

- **No business, rental income or employment expenses.**
 - **No capital gains or losses.**
 - **No bankruptcy.**
 - **No completing a final tax return for a deceased person.**
- Do you Rent? Bring landlord's (name on the cheque) name / amount.**
